*Last year, Bernie expressed to Michael Richter, his Direct Support Professional, that he wished to find his sister and have family in his life. They had lost track of each other when Bernie moved many years ago. After searching with no success, a private investigator was hired who specialized in finding family members, and Michael was able to make contact with Bernie's sister Paula, who now lives in Florida.*

*Paula came to visit Bernie early this month. They were truly joyful to be together again. The bond and love between these siblings is strong. Paula's love, compassion, and understanding is more than anyone could have hoped to find for Bernie. They have plans for Bernie to visit Paula in Florida and will stay in touch through phone and video chat in the meantime.*

Coarc is a not for profit service agency built over 50 years ago by families of those living with disabilities in order to provide appropriate and effective services to their loved ones. Today we continue to value each family as a critical partner as we continue to provide the best services we can and make them available to as many people as we can.


